Special Distribution for Perpetual High Grade Floating Rate Fund (the 'Fund')

We are writing to you to notify you that the Fund has made a special distribution.

The purpose of this special distribution was to ensure we are acting in the best interests of all unitholders in the Fund, as a whole, by providing all unitholders with their share of distributable income prior to a large transaction being processed. The amount you will receive will be shown in the distribution statement. You will be provided with a tax statement after the end of the 2026 financial year and will be required to include these amounts in your 2026 tax return.
