### Investment objective

To provide a balance of income and capital growth over the medium-to-long term. To outperform the option's composite benchmark over rolling three-year periods before fees and taxes.

### Investment strategy

The option allocates 50% of investments to growth assets to provide potential for capital growth managed by Realindex Investments using a systematic methodology. The property and infrastructure components are managed using market capitalisation indices. 50% of the portfolio is allocated to defensive assets to provide the portfolio with relatively stable returns. The portfolio aims to hedge currency risk except for the allocation to emerging market shares and part of the allocation to global shares.

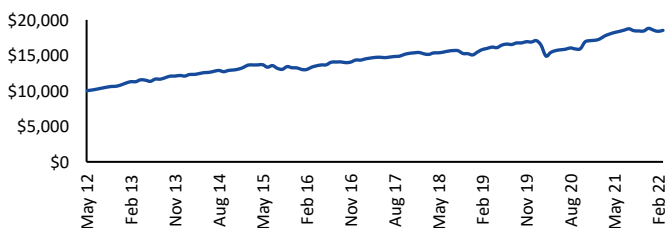

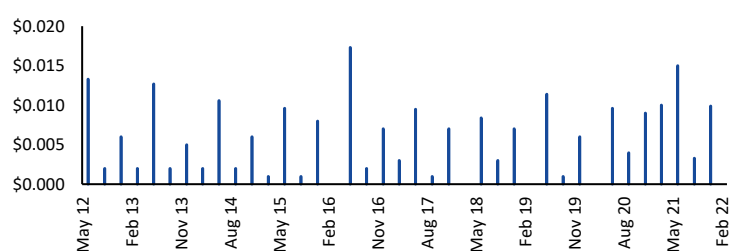

### Performance chart (\$10,000 invested since inception)

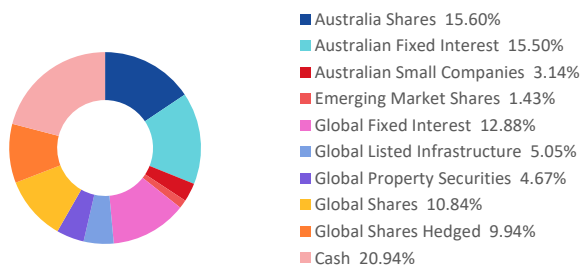

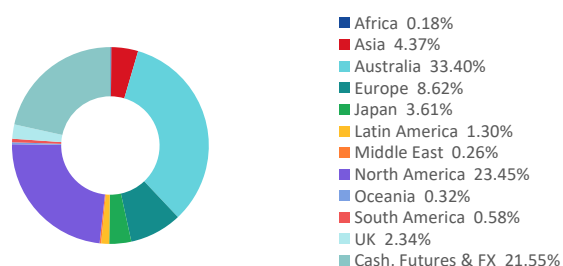
### Distributions (dollars per unit)
