Investment objective

To provide relatively stable returns over the medium term with the potential for some long-term capital growth. To outperform the option's composite benchmark over rolling three-year periods before fees and taxes.

Investment strategy

The option allocates 70% of investments to defensive assets to provide the portfolio with relatively stable returns. 30% of the portfolio is allocated to growth assets to provide potential for capital growth. The shares component is managed by Realindex Investments using a systematic methodology. The property and infrastructure components are managed using market capitalisation indices. The portfolio aims to hedge currency risk except for the allocation to emerging market shares and part of the allocation to global shares.

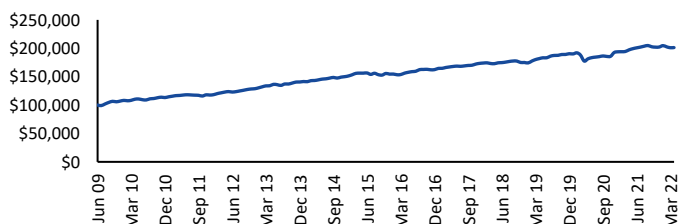

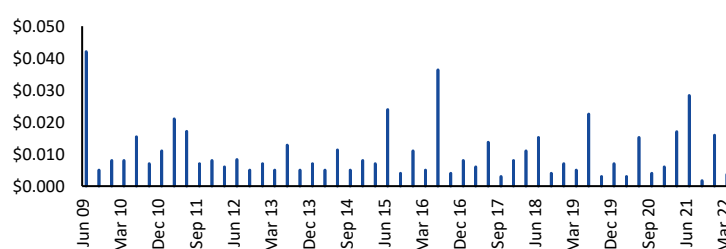

Performance chart (\$100,000 invested since inception)

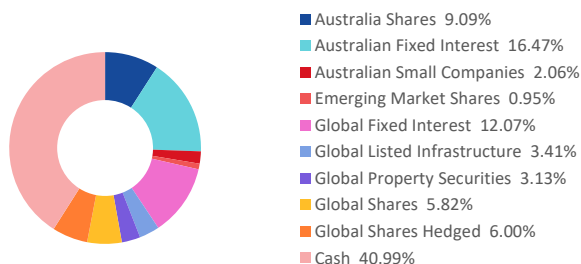

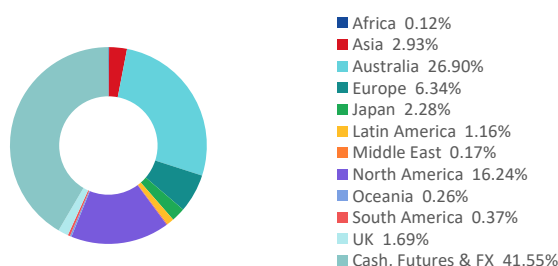
Distributions (dollars per unit)
