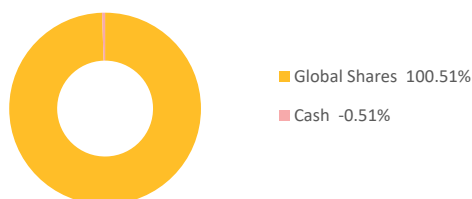

Asset allocation



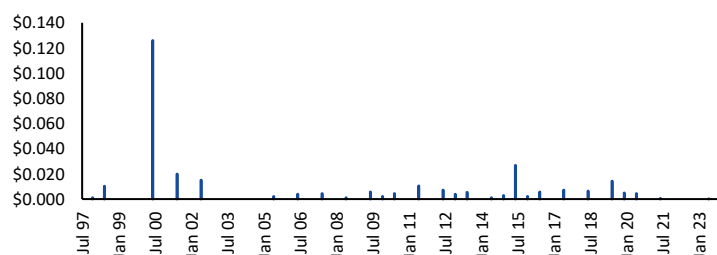

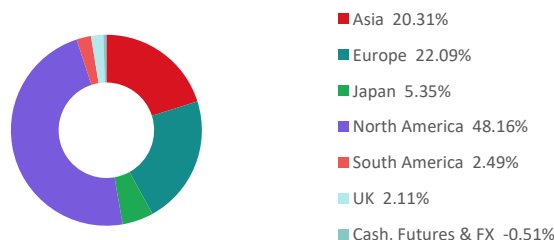

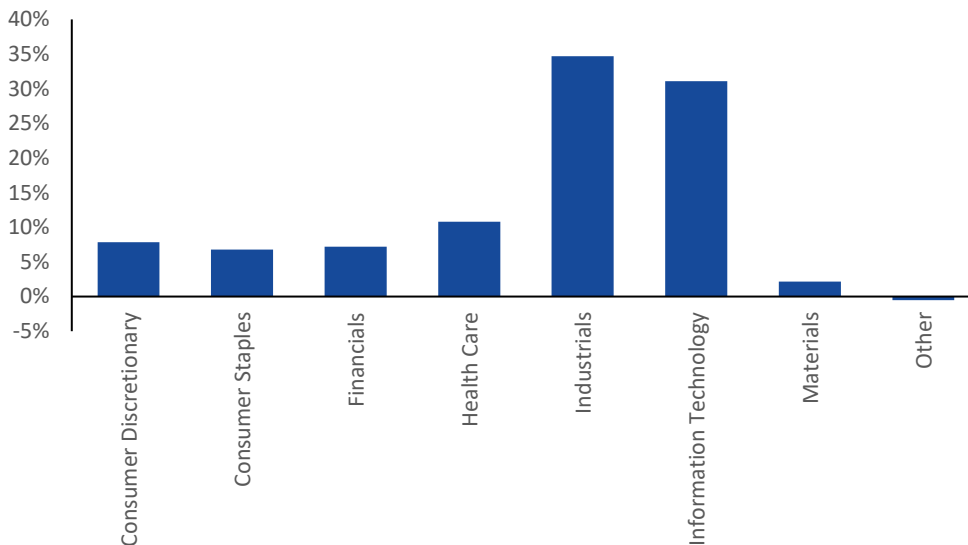
