The property and infrastructure components are managed to closely match the returns of relevant market capitalisation indices.

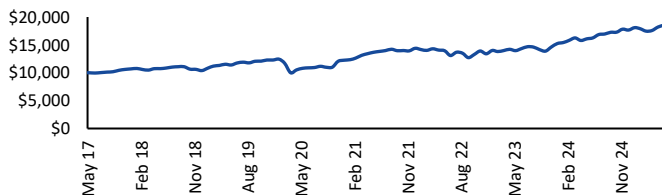

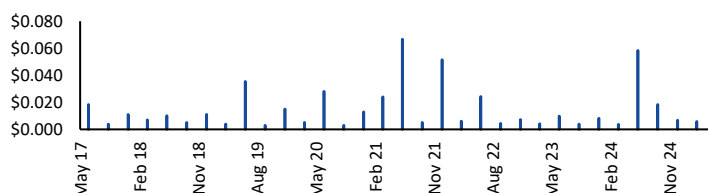

### Performance chart (\$10,000 invested since inception)

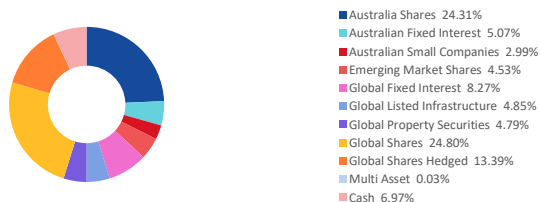

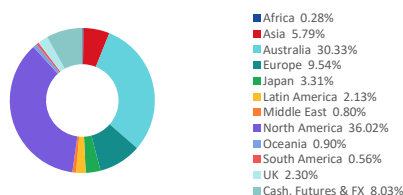
