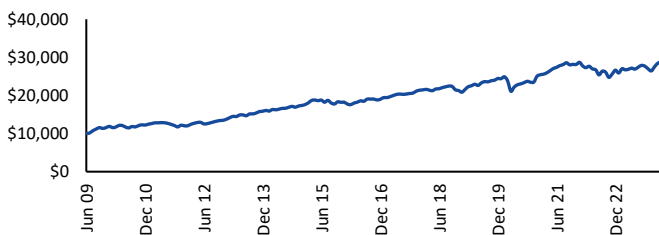

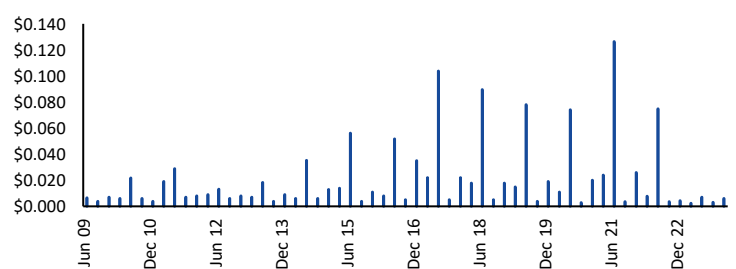

Performance chart (\$10,000 invested since inception)

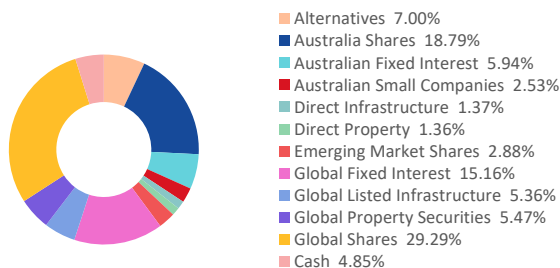

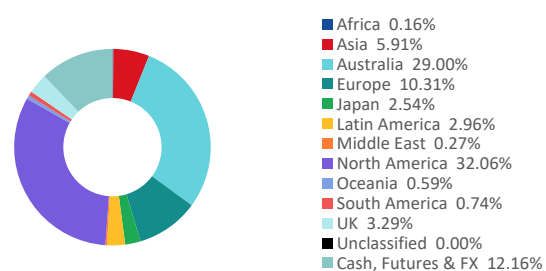
Distributions (dollars per unit)
