### Investment objective

To provide a balance of income and capital growth over the medium-to-long term. To closely track the fund's composite benchmark over rolling three-year periods before fees and taxes.

### Investment strategy

The option allocates 50% of investments to growth assets such as shares, property and infrastructure securities to provide potential for capital growth. The growth assets are managed using market capitalisation indices. 50% of the portfolio is allocated to defensive assets such as fixed interest and cash to provide the portfolio with relatively stable returns. The fixed interest component is managed on a traditional index basis while the cash component may include money market securities, bank deposits and annuities.

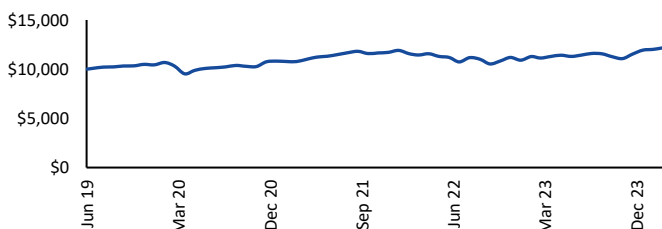

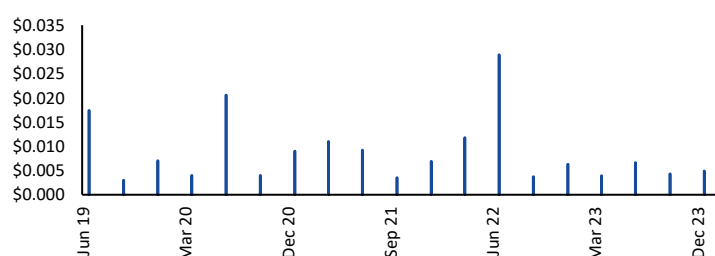

### Performance chart (\$10,000 invested since inception)

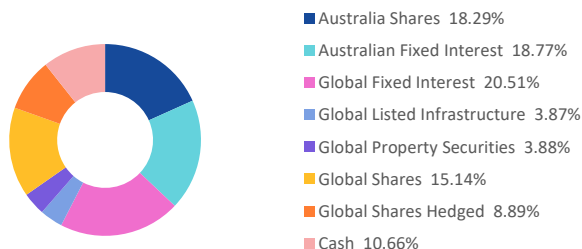

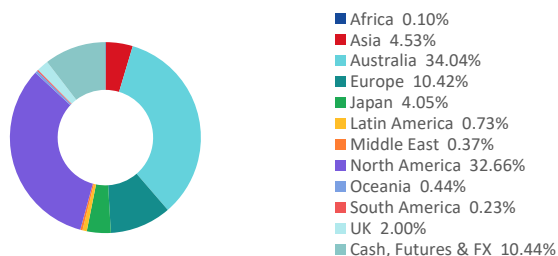
### Distributions (dollars per unit)
