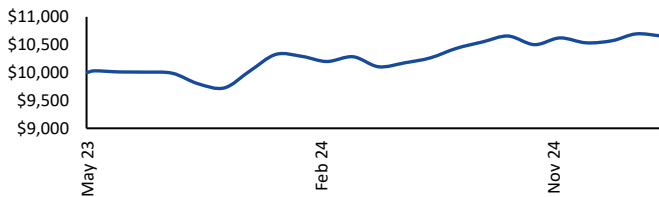

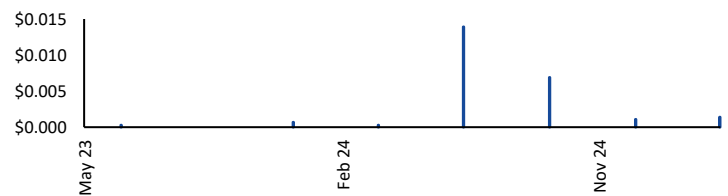

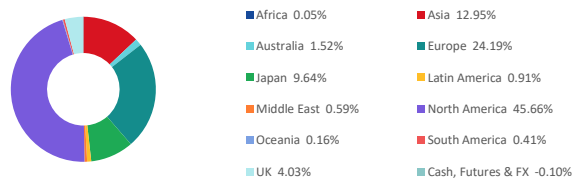
### Distributions (dollars per unit)
