Investment strategy

The option has a value-oriented philosophy towards investing in listed infrastructure and uses a relative value framework to determine both subsector and security weightings. Cohen & Steers believes success in global listed infrastructure investing requires a balance of top-down subsector research and bottom-up company specific analysis. Cohen & Steers anticipates the portfolio will comprise 30 to 60 investments. This option aims to hedge currency risk.

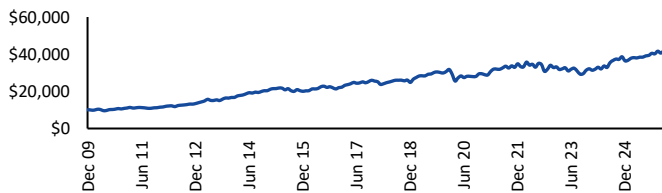

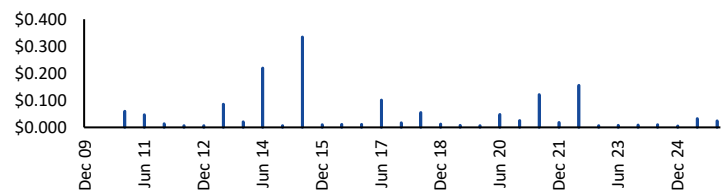

Performance chart (\$10,000 invested since inception)

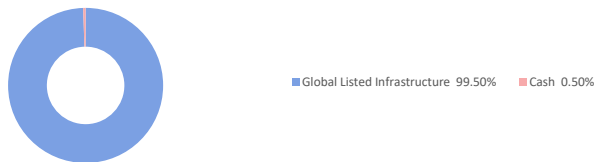

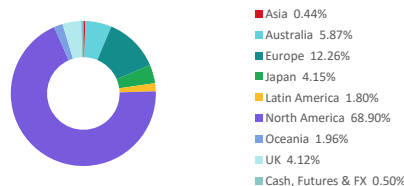
Distributions (dollars per unit)
